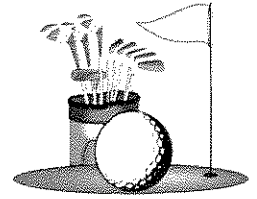


Village/Town of Somers Winter 2018 Youth Co-Ed Golf Clinic Information & Registration Form



Clinic Description: Ready to learn and have fun? The golf clinic offers a friendly introduction to golf basics to youth from 5-13 years old. A combination of teaching stations will take place in the lower level of the Village/Town Hall. Golf swing instruction into a hitting net, putting on artificial greens, short game, and physical fitness will be taught each week. A camera and I-pad for swing review will also be available.

Instructor: Dan Plens is a graduate of Golf Academy of America (09) and has spent the last 7 years as the Head Golf Professional at Lake Lawn Resort. His specialties are working with each player's own authentic swing, while providing sound instruction for each player to understand and grow their skills. While providing lessons to all ages, Plens is also a certified US Kids Golf Coach.
